## DIRECTIONS FOR USE

*SHAKE VIGOROUSLY BEFORE USING.*

**Organic BioLink® Zinc 8% Zn** can be applied to all crops including berries, citrus, cucurbits, field vegetables, fruiting vegetables, fruit trees, vines, leafy vegetables, root and tuber vegetables, row crops, strawberries, tree nuts, ornamentals, shrubs and flowers.

**Foliar Application:** Use 1/2 to 4 quart per acre. Apply to plant foliage to the point of run-off, throughout growing season as needed.

**Soil Application:** Use 1 to 4 quarts per acre. Apply in irrigation water, including drip and sprinkles.

**Nursery & Container:** Use 8 ounces per 100 gallons of water. Apply to plant foliage run-off or as a soil drench around base of plants. Repeat applications as needed.

**Phytotoxicity:** Always test spray mix on a small plot before large-scale application. To lower the risk of phytotoxicity, applications should be made early morning or late evening.

**Compatibility:** Always conduct a compatibility jar test before mixing **Organic BioLink® Zinc 8% Zn** with new products.

Use best management and cultural practices when applying **Organic BioLink® Zinc 8% Zn**. Use additional fertilizers as needed based on soil and tissue testing.
